1. ELIGIBILITY :

a) Age Limit for direct recruits:

18 to 30 years as on **01.07.2026** for UR/EWS [**Relaxable 5 years for SC/ST, 3 years for OBC (Non Creamy Layer)**], for Government Servants upto 40 years (45 years for SC/ST) in accordance with the instructions or orders issued by Central Government and for Ex- Serviceman upto a maximum of 3 years [08 (3+ 5) years for SC/ST and 06 (3+3) years for OBC] after deduction of the Military Service rendered from the actual age. The relevant certificate and caste certificate submitted in the prescribed format for appointment to posts under the Government of India will be considered for availing relaxation under EWS/Govt. Servant/SC/ST/OBC/ESM.

b) Educational & Other qualifications for direct recruits:

- (i) A Certificate in the respective trade from any Technical Institution recognized by the Govt. **OR** VIII Std. passed with experience of one year in the respective trade.
- (ii) Candidate who applies for the post of Mechanic (Motor Vehicle) should possess a valid Driving Licence (HMV & LMV) to drive heavy & light Vehicles.

2. METHOD OF SELECTION :

Selection of Skilled Artisans shall be made from, amongst the candidates possessing the requisite qualifications and valid driving licence [only for Mechanic (MV)] by means of Competitive Trade Test. The date and venue of the test with syllabus will be intimated separately to the eligible candidates at their correspondence address in Hall Permit. **No intimation will be sent in respect of other applicants who are not eligible.**

3. Application should be submitted as per application format attached. Applications which are not in prescribed format will be summarily rejected.

6. Candidates who wish to be considered against reserved vacancies and/or to seek age relaxation, must be in possession of relevant certificates [EWS/SC/ST/OBC (Non Creamy Layer) etc.] issued by competent/notified authority (in prescribed format) on or before the cutoff date (closing date of advertisement) otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise. The candidate has to select that particular category when applying for the post along with valid certificates. No request for change of category will be entertained at any later stage. The candidates who want to claim age relaxation for Government Servant need to submit relevant certificate/document that they have rendered minimum 3 years of regular service as government employee on cutoff date [i.e. last date of submission of application] (**The service should be rendered on same lines or in allied cadres**).
